## Scope and Purpose of Data Processing

For the preparation of offers, event bookings, and organization, the following personal data of the contractual partner are processed:

- Full name of the interested party, guest, and contact person, including address, telephone number, and email address
- Full name of the interested party and company, including address, telephone number, and email address

For offer preparation, the following personal data are processed:

First and last name, email, company phone number, company mobile phone, position/title

For event bookings, data are recorded in the Opera booking system and stored on an internal drive. Customer data are collected via a form.

The following personal data are collected for event bookings:

- First and last names of guests, if possible email address, food intolerances, vehicle license
  plates, credit card information, billing addresses (company or private), first and last name
  of accompanying person, VIP status, order number, cost centers, company VAT ID
- First and last name, email, mobile/phone number of the on-site contact person or authorized signatory



If booking and payment links are used, the customer provides their first name, last name, email address, phone number, mobile phone number, credit card information, and billing address (company/private) via an external link.

- Payment link = Freedompay
- Function/BEO = Opera

## Legal Basis for Data Processing

Data processing is solely for the purpose of event management. The legal basis for processing is the execution of the event contract according to Article 6(1)(b) GDPR.

# **Rights of Data Subjects**

As a data subject, you have the following rights with respect to Passenger Hotel Betriebsgesellschaft mbH:

- Right to access your stored data and its processing (Art. 15 GDPR)
- Right to rectification of incorrect personal data (Art. 16 GDPR)
- Right to erasure of your stored data (Art. 17 GDPR)
- Right to restriction of data processing if your data cannot yet be deleted due to legal obligations (Art. 18 GDPR)
- Right to object to the processing of your data (Art. 21 GDPR)
- Right to data portability if you have consented to data processing or entered into a contract (Art. 20 GDPR)
- Under Article 7(3) GDPR, you may revoke your consent at any time. This will mean we can no longer process your data based on that consent moving forward.
- Under Article 77 GDPR, you have the right to lodge a complaint with the Austrian Data Protection Authority (<u>www.dsb.gv.at</u>).

# **Recipients of Personal Data**

As part of using the Opera booking system, your data are transmitted to Oracle America Inc. Transmission to the USA occurs based on Oracle America Inc.'s certification under the Data Privacy Framework in accordance with Article 45(1) GDPR. Processing of your personal data is carried out under a data processing agreement in accordance with Article 28(3) GDPR.

### **Retention Period**

Your data are used exclusively for the event and deleted after the event ends, provided no legal retention requirements prevent deletion.
